On Monday September 18, 2023, at 9am in Rome, EFCL had an appointment with staff of the Dicastery (DICLSAL Dicastery for Institutes of Consecrated Life and Societies of Apostolic Life) to discuss the situation of religious institutes coming to completion in Australia.

EFCL is extremely appreciative of the efforts of Peter Jones osa, President of CRA, who secured this meeting on our behalf and to Mary-Clare Holland op, former Vice-President of CRA, who accompanied Anne Lane pbvm, Chair of the Emerging Futures Board, to the meeting.

We had hoped that this meeting would be the first of future meetings with Dicastery staff, giving us the opportunity to provide ongoing information about our circumstances in Australia. While the fact of ageing and diminishing numbers is a global reality, in Australia we face a number of other challenges due to our location, the small and scattered population and the ways in which religious institutes have faced up to the needs of ministries and property over the last thirty years. Anne emailed from Rome as they began their journey home: "Mary-Clare and I were delighted with our meeting with DICLSAL this morning. There were five members present some of whom had clearly read the material carefully. The meeting was clearly valued by them as much as by us. EFCL has been requested to meet with them each year to keep the dialogue going.

We appreciate the prayers of so many that led to this outcome. We felt the presence of the spirit in the room."
