
Register before November 4

In Board news, the first meeting of 2022 in late February has been cast as a workshop day preceded by an evening dinner to be held at Mary MacKillop Place, North Sydney. This will be the first inperson gathering for the Board and with directors from three states we hope the borders open and stay open! The Board plans to address two major issues: staffing and staff succession planning for EFCL and emerging issues in canonical governance.

On this latter issue, we have been fortunate to have a couple of Zoom meetings recently with canon lawyers from religious institutes in America, to gain insights into the way the role of canonical delegate is being addressed in the States and more specifically, how it is being addressed in the light of *Cor Orans*, the implementing instruction on women's contemplative life from the Vatican. There is always much to learn on this journey.

One fairly recent development is the growth in the number of engagements of the EFCL team members with the **members** of congregations with whom we are engaged. Typically we begin our work with a leadership team, but more and more now, we are attending congregational days or assemblies and working with the whole of the membership -on Zoom so far! We experience these gatherings as very enriching opportunities. But after two years of Covid restrictions, we look forward in 2022 to attending **in person** the service partner gatherings across the country in all states, metro and regional locations, to meet and work with all the congregational members.
